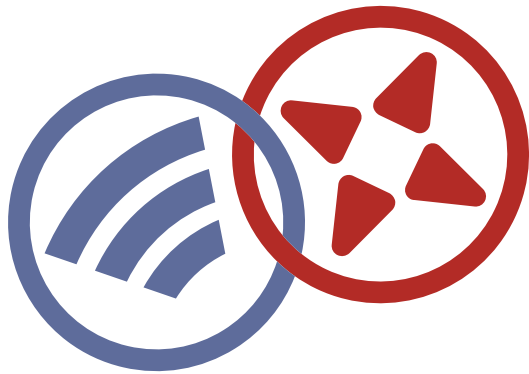

- Guardianship is a legal process where someone makes decisions for another person and has a big say in that person's life.

Facts about guardianship

Guardianship is an “old school” legal process that hasn’t changed much



Guardians are appointed when some people don’t *believe* that someone can make his or her own decisions

- ***BUT THAT’S NOT ALWAYS TRUE!***

Different kinds of guardianship

Rights under full guardianship

- Many rights are taken away

Rights under limited guardianship

- Depends on the court order
- You keep some of your important rights

In some cultures, families may want to take care of their family members, especially their children, forever

Believe in yourself!

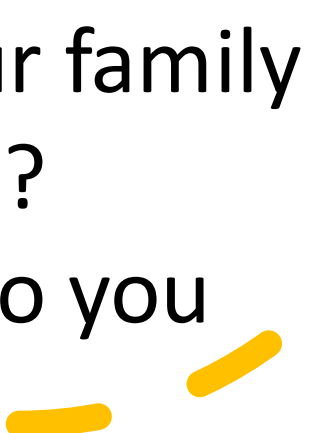
You should talk to other people who believe in you, too, so they can support you

You will have to go to court and file some papers

You may need a lawyer's help:

- contact your state's Protection and Advocacy agency!
